County Commissioner Jason Corley's Original Petition

To the Honorable Judge of Said Court:

Now comes Plaintiff County Commissioner for Lubbock County Precinct 2, Jason E. Corley (hereinafter "Commissioner Corley"), and files this his Original Petition, complaining of Mark A. Meurer (hereinafter "Meurer"), an individual purporting to serve as County Commissioner for Lubbock County Precinct 2. For cause of action, Commissioner Corley would show the Court:

A. Discovery Control Plan

1. **Level 2.** Commissioner Corley intends to conduct discovery under a Level 2 discovery control plan and affirmatively pleads that this suit is not governed by the expedited-actions process in Texas Rule of Civil Procedure 169.

B. Parties and Service

- 2. **Plaintiff.** Commissioner Corley is an individual and a resident of the State of Texas, and he brings this suit in his capacity as a public elected official, holding the office of County Commissioner for Lubbock County Precinct 2.
- 3. **Defendant.** Meurer is an individual and a resident of the State of Texas. As of December 8, 2025, Meurer purports to hold Corley's office as County Commissioner for Lubbock County Precinct 2. He may be served at his regular place of abode located at 1390 W. Crosby Street, Slaton, Texas 79364, at the Lubbock County Courthouse, located at 904 Broadway Street, Lubbock, Texas, or wherever he may be found.

C. Jurisdiction and Venue

4. **Subject matter jurisdiction.** This Court has subject matter jurisdiction over this matter because Commissioner Corley seeks a writ of quo warranto, injunctive relief, and declaratory relief, which this Court has the power to grant.¹

- **Personal jurisdiction.** This Court has personal jurisdiction over Meurer because he is a resident of this state.
- **Venue.** Venue is proper in Lubbock County because it is the county in which all or substantial portion of the events giving rise to Commissioner's Corley's claims occurred and is the County in which the elected office at issue—County Commissioner for Lubbock County Precinct 2—is located.

D. Background Facts

- Commissioner Corley's election to office. In 2019, Commissioner Corley was elected to his first term of office as County Commissioner for Lubbock County Precinct 2, and he was reelected to that office on November 8, 2022.
- Corley's service as county commissioner and current term of **office.** Corley has served as the County Commissioner for Lubbock County Precinct 2, representing tens of thousands of Lubbock County Citizens, since 2019, and he has fulfilled his obligations of office and remains eligible to hold said office. His current four-year term of office began on January 1, 2023, and will expire on December 31, 2026. One year and thirty days before December 31, 2026, was December 1, 2025.
- 9. **Legal background.** The law provides that an elected official holding state or county office with more than a year and one month remaining in their current term automatically resigns their current office if they (a) announce their candidacy or (b) in fact becomes a candidate for another elected office.²
 - a. An announcement is a statement made in a public setting or a statement that is otherwise available to the public.
 - b. A person in fact becomes a candidate when they apply to appear on the ballot.3

A private, confidential statement made to a non-media person will ordinarily not trigger Texas Constitution, Article XVI, § 65(b) because such a statement does not constitute an announcement or make someone a candidate for office.

Corley's exploratory committee. On or about November 12, 2025, Corley launched an exploratory committee to evaluate a run for US Congress for

Texas District 19. He did not, by virtue of creation of or announcement of an exploratory committee, announce his candidacy or in fact become a candidate for another elected office.

- 11. **Corley did not announce candidacy for Texas District 19 before December 2, 2025.** Commissioner Corley first announced his candidacy for Texas District 19 on December 2, 2025, when the unexpired term of Commissioner Corley's office was one year and 29 days. On December 2, 2025, Commissioner Corley announced his candidacy for Texas District 19. Commissioner Corley attaches hereto as Exhibit A his first press release for his candidacy for election to the US House of Representatives for Texas District 19, which was distributed to members of the media on December 2, 2025, and not before.
- 12. **Corley did not become a candidate for Texas District 19 before December 3, 2025.** Commissioner Corley first became a candidate for Texas District 19 on December 3, 2025, when the unexpired term of Commissioner Corley's office was one year and 28 days. On December 3, 2025, Commissioner Corley applied to be placed on the ballot. Commissioner Corley attaches hereto as Exhibit B his application to be placed on the ballot for Texas District 19, which was filed with the Chair of the Republican Party of Texas on December 3, 2025, and not before.
- Judge Curtis Parrish's attempt to expel Corley from office. The Lubbock County Judge, Curtis Parrish, concluded that Commissioner Corlev is a candidate for another office relying on the extremely broad definition of "candidate" in Elections Code section 251.001(1), which does not even apply to candidates for election to the U.S. House of Representatives.⁴ Based on this erroneous application of the law, on December 8, 2025, at approximately 9:00 am, Parrish attempted to expel Corley from office. At that time, Judge Parrish requested Corley to come to Parrish's office to discuss a loan for a volunteer fire department, but this was not the real reason Judge Parrish wanted to meet Commissioner Corley. When Commissioner Corley arrived in Parrish's office, Parrish was accompanied by two Lubbock County Sheriff Deputies. Parrish handed Corley the document attached hereto as Exhibit C, which purports to "announce" that Lubbock County Commissioner Precinct 2 is vacant by "the automatic resignation of Jason Corley under the provisions of the Texas Constitution and the Texas Elections Code." The Lubbock County Sheriff Deputies escorted Corley to his office in the commissioner's court suite of the Lubbock County Courthouse and required that he pack his belongings. They then escorted him out of the commissioner's court suite.

Judge Parrish not only applies the wrong definition of "candidate," but also takes the position that Texas Constitution Article XVI, §65(b) is triggered by the fact that Commissioner Corley announced he was launching an exploratory committee and/or engaged in private, confidential conversations.

- 14. Corley still holds office. Since Corley first announced his candidacy and/or became a candidate for Texas District 19 with less than only one year and thirty days remaining in his current term,⁶ Corley has not resigned as County Commissioner for Lubbock County Precinct 2, and Corley still holds said office.
- 15. **Meurer "sworn in" and participating in Commissioner's Court.** Promptly after Lubbock County Sheriff Deputies escorted Commissioner Corley from the Lubbock Courthouse, Judge Parrish purported to administer the oath of office for County Commissioner for Lubbock County Precinct 2 to Meurer, despite the fact that there was no vacancy for said office. Meurer now purports to occupy the office of County Commissioner for Lubbock County Precinct 2 and even sat upon the dais in commissioner's court on December 8, 2025, despite the fact that there was no vacancy for said office.

E. Count 1 – Application for Writ of Quo Warranto

- 16. **Grounds for quo warranto.** The Court should issue a writ quo warranto should because Meurer usurps, intrudes into, or unlawfully holds the office of County Commissioner for Lubbock County Precinct 2, which office is rightfully held by Commissioner Corley.
- 17. **Requested relief.** Commissioner Corley requests the Court issue a writ of quo warranto to determine that he, not Meurer, is entitled to hold the office of County Commissioner for Lubbock County Precinct 2 and exercise its functions.

F. Count 2 - Petition for Declaratory Relief

- 18. **Justiciable controversy.** There is a justiciable controversy about the rights and status of the parties—to wit: whether Commissioner Corley or Meurer holds the office of County Commissioner for Lubbock County Precinct 2—and the declaration sought herein would resolve that controversy.
- 19. **Requested relief.** Commissioner Corley requests that the Court promptly issue a declaratory judgment to declare:
 - a. That Corley did not automatically resign the office of County Commissioner for Lubbock County Precinct 2 by announcing his candidacy for Texas District 19 or becoming a candidate for Texas District 19 with more than a year and one month remaining in his current term.
 - b. That Commissioner Corley, not Meurer, rightfully holds the office of County Commissioner for Lubbock County Precinct 2.

G. Count 3 – Verified Application for Injunctive Relief

- 20. **Grounds.** Commissioner Corley is entitled to a writ of injunction:
 - a. Under the principles of equity and the laws of Texas relating to injunctions;
 - b. Because he is entitled to the relief demanded, and all or part of the relief requires the restraint of some act prejudicial to the applicant; and/or
 - c. Because Meurer performs or is about to perform, or is procuring or allowing the performance of, an act relating to the subject of pending litigation, in violation of the applicant's rights, and the act would tend to

render the judgment in that litigation ineffectual.

- 21. **Probable recovery.** It is probable that Commissioner Corley will prevail after a trial on the merits because Corley did not announce his candidacy for Texas District 19 and did not, in fact, become a candidate for that office, until December 2, 2025, when the unexpired term of the office Corley holds was less than one year and 30 days.
- 22. **Imminent, irreparable harm.** If Commissioner Corley's application is not granted, harm is imminent because Meurer has usurped the office of County Commissioner for Lubbock County Precinct 2. The harm that will result if the temporary restraining order is not issued is irreparable because Commissioner Corley was elected to represent the constituents of Lubbock County Precinct 2. Commissioner Corley is entitled to hold the office to which he was elected and did not resign.
- 23. **No adequate remedy at law.** Commissioner Corley has no adequate remedy at law because damages would not provide complete relief and would not vindicate the rights of Corley's constituents to be represented by their elected representative.
- 24. **Not sufficient time for notice and hearing.** There is not enough time to serve notice on Meurer and to hold a hearing on this application. Meurer presently purports to occupy and exercise the rights and duties of office of County Commissioner for Lubbock County Precinct 2.
- 25. **Request for temporary injunction.** Commissioner Corley asks the Court to set his application for temporary injunction for a hearing and, after the hearing, issue a temporary injunction against Meurer enjoining Meurer from acting as the County Commissioner for Lubbock County Precinct 2.
- 26. **Request for permanent injunction.** Commissioner Corley asks the Court to set his request for a permanent injunction for a trial on the merits and, after the trial, to issue a permanent injunction against Meurer enjoining Meurer from enjoining Meurer from acting as the County Commissioner for Lubbock County Precinct 2 until such time as Corley's current term of office ends.
- 27. **Bond.** Commissioner Corley is ready and willing to post an injunction bond.

H. Conditions Precedent

28. All conditions precedent to Commissioner Corley's recovery for the relief requested herein have been performed or have occurred.

I. Prayer

For the foregoing reasons, Commissioner Jason E. Corley prays that Mark Allen Meurer be cited to appear and that the Court issue a writ of quo warranto determining that Corley, not Meurer, has the right to hold the office of County Commissioner for Lubbock County Precinct 2, award Commissioner Corley the declaratory and injunctive relief requested herein, and for such other relief to which he may be entitled under law or equity.

STATEMENT REGARDING AUTOMATIC RESIGNATION OF COMMISSIONER JASON CORLEY

On November 12, 2025, Lubbock County Commissioner Jason Corley became a candidate in fact for U.S. House of Representatives.

The Texas Constitution, Article XVI, Section 65 states that if a County Commissioner becomes a candidate in fact for "any office of profit or trust," prior to one year and 30 days before the expiration of their term of office, then such candidacy constitutes an "automatic resignation of the office then held."

The Texas Election Code, Sec. 251.001 (1) defines a candidate as someone who takes an "...affirmative action for the purpose of gaining nomination or election to public office..." The Code list examples of an Affirmation Action including:

before a public announcement of intent, the making of a definite intent to run for public office and the soliciting of support by letter or other mode of communication; *Tex. Election Code* $\S 251.001 (1)(F)$

the soliciting or accepting of a campaign contribution or the making of a campaign expenditure; Tex. Election Code § 251.001 (1)(G)

Congress. In an e-mail sent on November 12, 2025 to media outlets across Texas, Mr. Corley stated he was forming an exploratory committee to assess the level of public support for his campaign for Congress. This e-mail was sent by Jason Corley from a "Corley for Congress" e-mail address. Attached to the press release were two "Corley for Congress" campaign graphics, a "Corley for Congress" post office box address in Slaton, and a media contact person also using a "Corley for Congress" e-mail address.

On Saturday, November 15, 2025, Jason Corley sent a text message to an individual soliciting that person's support. Mr. Corley stated in the text message:

"...my name is Jason Corley. I am the County Commissioner for Lubbock County precinct 2. I'm running for Congress in congressional district 19."

Based on the above statements made by Jason Corley prior to one year and 30 days before the expiration of his term of office, I, Lubbock County Judge Curtis Parrish, by the authority granted to me by the Constitution and Laws of the State of Texas, do hereby announce that the office of Lubbock County Commissioner Precinct 2 is VACANT by the automatic resignation of Jason Corley under the provisions of the Texas Constitution and the Texas Election Code.
